





## Kijima Kogen Park Terms of Use

I. Conditions meriting refusal of entry to or expulsion from Kijima Kogen Park (hereinafter referred to as "Park") premises.

## (Refusal of entry)

A. The Park may refuse entry to persons in the following cases.

- 1. If persons intending to use the Park are considered to be:
  - Members of or affiliated with organized crime groups or related corporations/organizations as well as other antisocial forces (hereinafter collectively referred as "organized crime and other antisocial forces"),

Members of or affiliated with corporations or organizations whose business activities are controlled by organized crime and other antisocial forces,

Members of or affiliated with corporations whose executives include members of organized crime and other antisocial forces, Heavily intoxicated or in a state close to severe intoxication.

- 2. Persons with a risk of exhibiting behavior that may cause significant disturbance to other Park visitors, and may be detrimental to the Park's management.
- 3. Persons with a risk of making violent demands or unreasonable requests to the Park or its employees.
- 4. Persons with a risk of engaging in prohibited activities as stipulated in these Terms of Use.
- 5. Persons with a risk of engaging in actions including those aforementioned that would benefit organizations likely to engage in collective or habitual violent illegal acts.

(Discontinuation of Service, Expulsion, and Reporting to Law Enforcement Authorities)

B. The Park may discontinue services to and expel persons from the premises in the following cases.

- Persons who fail to comply with Park requests will be reported to law enforcement authorities.
- 1. If persons using the Park are discovered to be:
  - Members of or affiliated with organized crime and other antisocial forces,
  - Members of or affiliated with corporations or organizations whose business activities are controlled by organized crime and other antisocial forces,

Members of or affiliated with corporations whose executives include members of organized crime and other antisocial forces, Heavily intoxicated or in a state close to severe intoxication.

- 2. Persons exhibiting behavior that is causing significant disturbance to other Park visitors.
- 3. Persons making violent demands or unreasonable requests to the Park or its employees.
- 4. Persons engaging in prohibited activities as stipulated in these Terms of Use.
- II. The following acts are prohibited within the Park.
  - · Entry with pets (excluding guide dogs, hearing dogs, or service dogs)
  - Riding skateboards, kickboards, inline skates, etc.
  - · Bringing in and using tents or garden parasols
  - · Bringing in and using fire sources such as BBQ grills or fireworks
  - All ball game activities
  - · Bringing in and using unmanned aerial vehicles such as drones
  - · Smoking while walking and smoking outside designated areas
  - Riding motorcycles or bicycles
  - · Unauthorized business activities, distribution of flyers, advertising activities, gatherings, or speeches
  - · Unauthorized recording, video recording, or photography for commercial purposes
  - Ticket scalping, such as buying and selling or reselling admission tickets
  - Bringing in dangerous items such as explosives, firearms, or swords
  - Acts that disturb the safety, public morals, or order within the Park, causing nuisance and discomfort to others
  - · Any acts that interfere with the operation of the Park
